



**Notification by Members of a Parish/Town Council of Pecuniary and other registerable interests.**

**Localism Act 2011, Sections 28 &29**

**The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012**

In order to comply with their Code of Conduct, a Member or Co-opted Member ("M") must register their pecuniary and interests other than pecuniary interests with Allerdale Borough Council's Monitoring Officer within **28 days** of the date of their election or co-option (Failure to declare a disclosable pecuniary interest is a criminal offence).

**Important Notes –**

You may complete the form electronically but you must print out and personally sign the completed form.

If in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid the risk of not registering something in error.


